Illness or Injury

A medical deferral requires a doctor's certificate to be submitted to the Undergraduate Academic Counsellor, Diane Mills in TC210 (for undergraduate students) or the Graduate Program Assistant, Audrey Yardley-Jones in TC216 (for graduate students). The MPS Department Chair, Dr. Sophie Roland, decides whether to grant the deferral. There is no fee for a deferral of chamber music recital based on illness, injury or compassionate grounds. Questions regarding appropriate medical documentation should be directed to Diane Mills in TC210. Note that professional engagements, auditions, or failure to confirm in advance the chamber music coach's availability will not routinely constitute grounds for deferral. Failure to follow the above procedure may result in members of the group receiving a grade of "0" for the portion of their course grade constituted by the missed Graded Recital.

Compassionate Grounds

For deferrals based on compassionate grounds, (generally a significant family emergency), submit the deferral form to the Undergraduate Assistant, Catherine Fraser in TC210. You must send additional supporting documentation of a compassionate grounds request by email to the MPS Department Chair, Dr. Sophie Roland <u>sroland2@uwo.ca</u> Note that professional engagements, auditions, or failure to confirm in advance the chamber music coach's availability will not routinely constitute grounds for deferral.

There is no fee for a deferral of chamber music recital based on illness, injury or compassionate grounds. Failure to follow the above procedure may result in members of the group receiving a grade of "0" for the portion of their course grade constituted by the missed Graded Recital.
