CELLO JURY REQUIREMENTS

General Information: Please read carefully:

For each jury, three (M1140) or four (all music major juries) categories are to be performed as listed.

1) Category 1.

- "Pieces" refers to movements from concertos or sonatas, or concert pieces
- Playing from memory will enhance the jury grade, except with sonatas for cello and piano, where playing from memory will not affect the grade.

2) Category 2.

- Studies (or Caprices) need not be performed from memory.

3) Category 3.

- Candidates should be prepared to play from memory all technique listed for each jury. The jury panel will hear excerpts from this list. (Any desired bowing).

4) Category 4.

- (where applicable):

Orchestral Excerpts are to be taken from Prof. Wiebe's library, or when designated, from Orchestral Excerpts, International Edition.

-Major and minor arpeggios of C, D, Eb and F, 3 octaves
-6ths: C major, 2 octaves

- 4) Orchestral Excerpts (from Orchestral Excerpts, International Edition):
 - a) Beethoven Symphony No. 1, *Allegro con brio*, 1st mvt, lines 2-4
 - b) Schubert Symphony No. 8, *Allegro moderato*, lines 1-3
 - c) Tchaikovsky Piano Concerto No. 1, 1st mvt, lines 4-7 (where *Allegro con spirito* starts)

3) Technique: -Major, harmonic and melodic minor scales of C, D, 3 octaves.

-Major & minor arpeggios of C, D, 3 octaves.

 - b) 2 contrasting movements from a Bach Suite
 - c) first movement of a major sonata

- 2) Studies: One study from Popper High School, Op. 73

- 3) Technique:
 - All major, harmonic and melodic minor scales, 3 octaves
 - All major and minor arpeggios, 3 octaves
 - Dominant 7th arpeggios beginning on the notes C, D and F, 3 octaves
 - Diminished 7th arpeggios beginning on the notes C, D and F, 3 octaves
 - 3rds: C, D and Eb Major, 2 octaves
 - 6ths: C, D and Eb Major, 2 octaves
 - 8ves: C and D Major, 2 octaves

- 4) Orchestral Excerpts (from Orchestral Excerpts, International Edition):
 - a) Mozart Symphony No. 35, lines 5-8 (where *Presto* starts)
 - b) Tchaikovsky Symphony No. 6, *Allegro con grazia*, lines 1-6

- 1) First or last movement of a major concerto, or a substantial part of a one-movement work or set of variations for cello and orchestra
- 2) Orchestral Excerpts
 - a) Beethoven, Symphony No. 5,
2nd mv't: measures 1-10; 98-106;
3rd mv't: 140-177
 - b) Mozart, Marriage of Figaro, measures 1-7; 2 before reh. 8 until reh. 8; reh. 9 for 9 measures
 - c) Rossini, Overture "William Tell" solo, top voice only, from beginning until *Allegro*

M3930b RECITAL

A variety of styles should be presented.

NOTE: One Canadian composition must be included in either the M3926 recital or the M4926 recital.
Minimum level: Contemporary Showcase: "Advanced."

Time: 35-45 minutes of music (no intermission) - see Handbook

M3924Y (formerly M375y) Two or more contrasting works, a technical study, and 2 contrasting orchestral excerpts to total the time of the jury which shall be no less than 15 minutes. The teacher shall choose the repertoire and level.

M4924Y (formerly M475y) Two or more contrasting works, a technical study, and 2 contrasting orchestral excerpts to total the time of the jury which shall be no less than 15 minutes. The teacher shall choose the repertoire and level.

 -Major, harmonic and melodic minor scales of G and A, 3 octaves
 -Major and minor arpeggios of C, D, Eb, 4 octaves
 -Major and minor arpeggios of G and A, 3 octaves
 -3rds: C and D Major, 3 octaves
 -6ths: C, D and Eb Major, 3 octaves
 -8ves: C, D and Eb Major, 3 octaves

 - a) Brahms: 2nd Piano Concerto in Bb, 3rd mv't only
Solo part only, measures 1-9; 13-25; 71-end of mv't
 - b) Mozart Symphony No. 40, *Allegro molto*, lines 1-4
 - c) Verdi: Offertorio from *Requiem*
measures 1-28

Note: The jury, scheduled at the end of Term I, will consist of two parts:

- 1) First or last movement of a major concerto, or a substantial part of a one-movement work or set of variations for cello and orchestra
- 2) Orchestral Excerpts (from Orchestral Excerpts, International Edition)
 - a) Debussy *La Mer*, p. 23, 1st 2 systems, top voice only
 - b) Tchaikovsky: *Swan Lake*, p. 57, solo lines 2-5
 - c) Mendelssohn *Scherzo* from *Midsummer Night's Dream*, p. 41, first 7 lines
