**COURSE INFORMATION & SYLLABUS**

**Course Description:** The first semester of the course examines standard clarinet repertoire and composers and organize these in relation to the instrument's historical development, prominent makers, and influential performers. The second semester involves detailed examination of teaching methodology involved in one-to-one clarinet instruction of beginner to intermediate levels and an exploration of pedagogical resources, diagnostic skills and teaching strategies.

**Objectives:** As a result of the complete course, the student will be able to:

- 1) Demonstrate the understanding of the clarinet's historical development by creating a timeline.
- 2) Connect significant clarinet works, from its Baroque beginnings to the present and in numerous musical forms (concerti, sonatas, solos, unaccompanied, and small chamber works) to the created timeline.
- 3) Examine the influence of notable performing artists on the clarinet's acoustic development and repertoire creation.
- 4) Develop the ability to explain the construction of the modern clarinet and its fundamental acoustic properties.
- 5) Analyze commonly used clarinet method books in North America today and identify their use for different levels and types of learners.
- 6) Compile, evaluate and demonstrate common pedagogical methods and equipment used in the teaching of clarinetists of various levels. These methods involve the development of diagnostic abilities, suitable communication of performance concepts and recommendations of useful resources and practice material. This will be evaluated through written work, and class discussions.

**Time Commitment:**

- 1) 1.5 hour weekly class; Thursdays, 1:30pm – 3pm
- 2) outside of class - reading, watching videos, research & assignments
