### **COURSE DESCRIPTION**

Intensive study of French mélodie and its composers, including stylistic and poetic influences and considerations in research and performance, from early mélodie to current compositions. Refined pronunciation of the language is an essential aspect of the performances.

## COURSE OBJECTIVES

By the end of this course students will demonstrate knowledge of composers of French mélodie and their works, including Canadian and contemporary French composers. Students will understand the correct interpretive style and language use for singing mélodie and employ it in performance. They will develop knowledge of the historical development of the mélodie and the influences on its development while planning and giving presentations. This knowledge will lead to performances in which students will implement correct pronunciation of French lyric diction, expressing understanding of the syntax, word stress and important poetic texts of the French language.

This course will involve research projects, which will be presented as lecture performances every two to three weeks. Written work with sources and footnotes to be provide to me. Limit your use of online resources, and document those used. Keynote, Powerpoint, recordings, paper and berets, etc. may be used in presenting your research. Song performances do not need to be memorized. There will be discussion following the presentations. Students are requested to take notes and formulate questions for this purpose. Further research activities may be added. It is essential to determine your songs in the first three weeks, and provide the pianist assigned to the class with the scores. The due date for the scores is SEPTEMBER  $23^{\rm rd}$ .
